

SWAN RIVER DRESSAGE INC NEW MEMBERSHIP APPLICATION - 2021

Swan River Dressage Inc (SRDI) fosters the development of riders and officials through friendly and inclusive events. We offer the full range of competitions from Preliminary to Grand Prix, as well as the opportunity to participate in other activities such as protocol days (training days), clinics and workshops. We place a high value on sportsmanship and reward people who are there in the spirit of the sport, whether riders, supporters or volunteers.

Classes of membership and fees for 2021

- Ordinary membership rider class: (for people 16 years and over who intend to ride in SRDI events)
 Annual membership fee: \$80
- Ordinary membership non-rider class: (for people 16 years and over who will not be riding at SRDI events, but will otherwise have the same membership privileges as rider members)
 Annual membership \$25
- Junior class: (for people under 16 years of age; may ride in Swan River Dressage events, but not
 entitled to vote at meetings or be on the committee)
 Annual membership fee \$80

Benefits of membership (except non-rider class)

- Discount on entries to SRDI competition events \$10 discount per test for open competitions (4 open competition days are planned for 2019)
- Eligibility for SRDI Leaderboard Series Championship rugs (for members only)
- Eligibility for SRDI Dressage Festival garlands (for members only)
- Early email notification of entries opening for competitions on Nominate
- Priority entry to Protocol Days and Clinics with highly-credentialed judges and visiting judges with international judging experience
- Eligibility to ride in Restricted SRDI Events (& possibly Club Days)
- Highly-credentialed judges, coaches, judge educators & mentors
- Opportunity to compete in a friendly & supportive environment

SRDI is affiliated with Equestrian Western Australia (EWA). It operates under EA's Rules & Regulations, (see www.wa.equestrian.org.au or www.equestrian.org.au).

Safety

Safety is paramount, and if the behaviour of any participant or horse is deemed by the Organising Committee (OC) to be potentially dangerous in any way, the OC may prevent the participant or horse from participating. Participants must make themselves aware of any safety notices before riding at any SRDI events.

Dangerous activity acknowledgement

In consideration of being permitted to participate in any way in horse sport activities, I, the undersigned, understand, acknowledge and accept that:

- 1. Horse sports are dangerous activities and horses can act in a sudden and unpredictable (changeable) way, especially if frightened or hurt.
- 2. There is a significant risk that serious INJURY or DEATH may result from horse sport activities.
- 3. There are dangers associated with the consumption of alcohol or drugs, and agree not to drink alcohol or take drugs before or during any SRDI horse sport activities.
- 4. I must follow the directions of any event organiser or official and that any misconduct or refusal by me to follow any direction of any organiser or official can result in the CANCELLATION of my participation in the activities and my immediate removal from my horse NO MATTER where that may occur.
- 5. I must wear an approved helmet at all times whilst participating in the sport where this is required under the relevant EA rules and regulations.
- 6. I have had sufficient opportunity to read this Dangerous Activity Acknowledgement and fully understand its terms and sign it freely and voluntarily.

- 6. I acknowledge that I have sole responsibility for my personal possessions and equipment during the event and related activities.

- 8. I hereby consent to receive medical or veterinary treatment for me and/or my horse/s, which may be deemed advisable by those present in the event of injury, accident and/or illness during the event.
